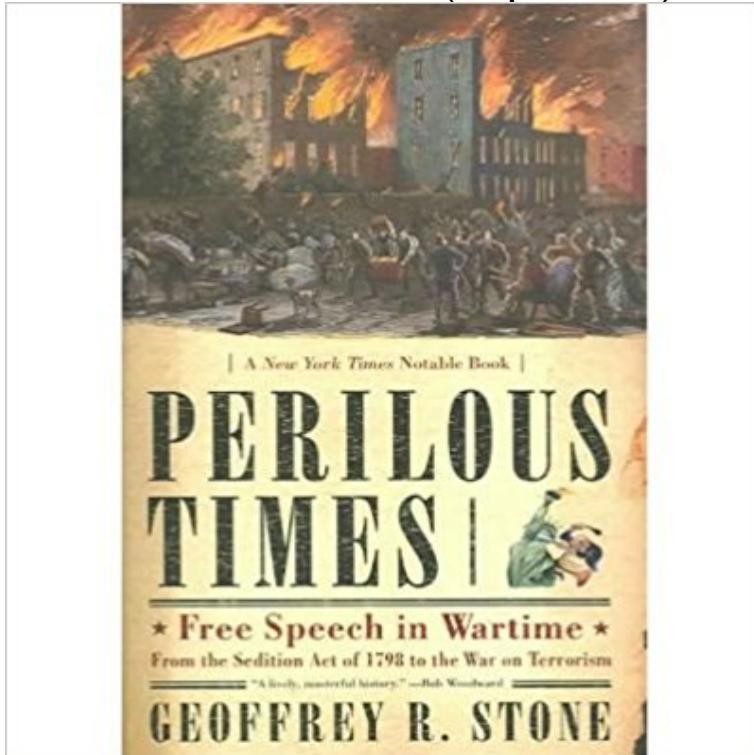


## Perilous Times: Free Speech in Wartime from the Sedition Act of 1798 to the War on Terrorism (Paperback) - Common
