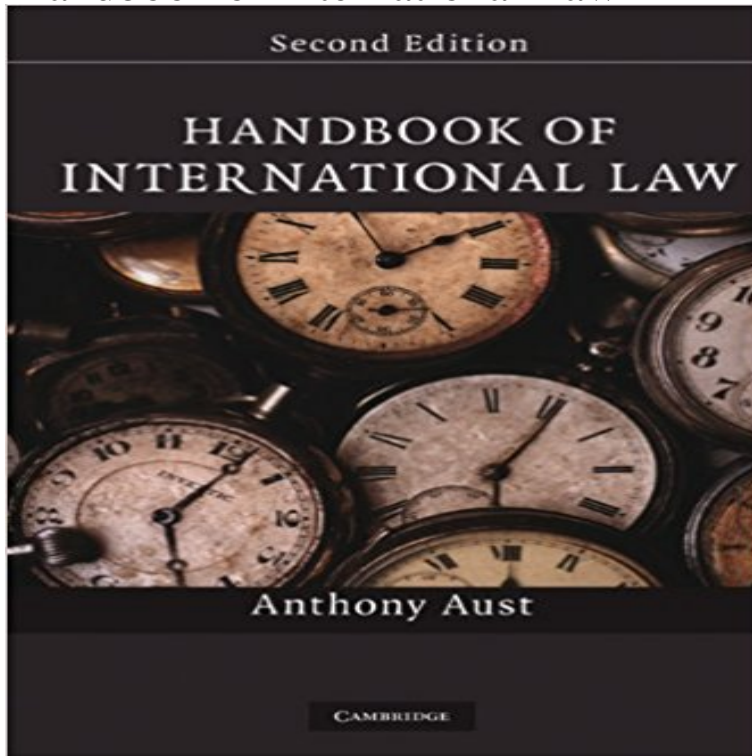


# Handbook of International Law
