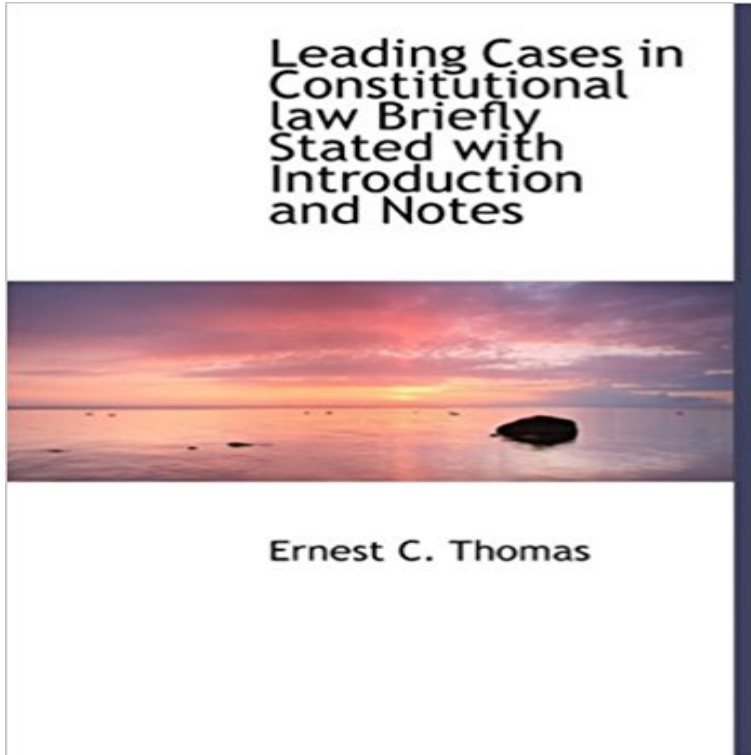


Leading Cases in Constitutional law Briefly Stated with Introduction and Notes
