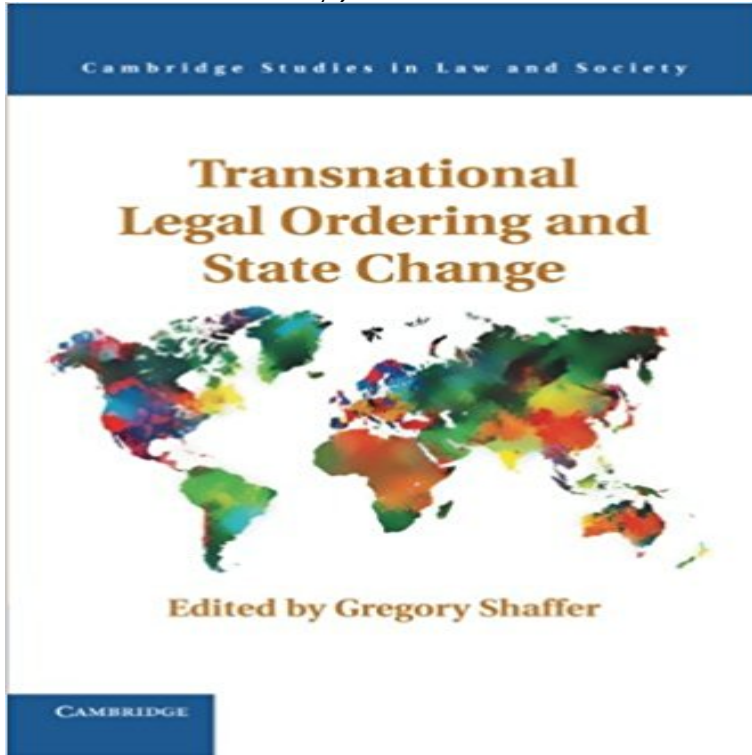


Transnational Legal Ordering and State Change (Cambridge Studies in Law and Society)
