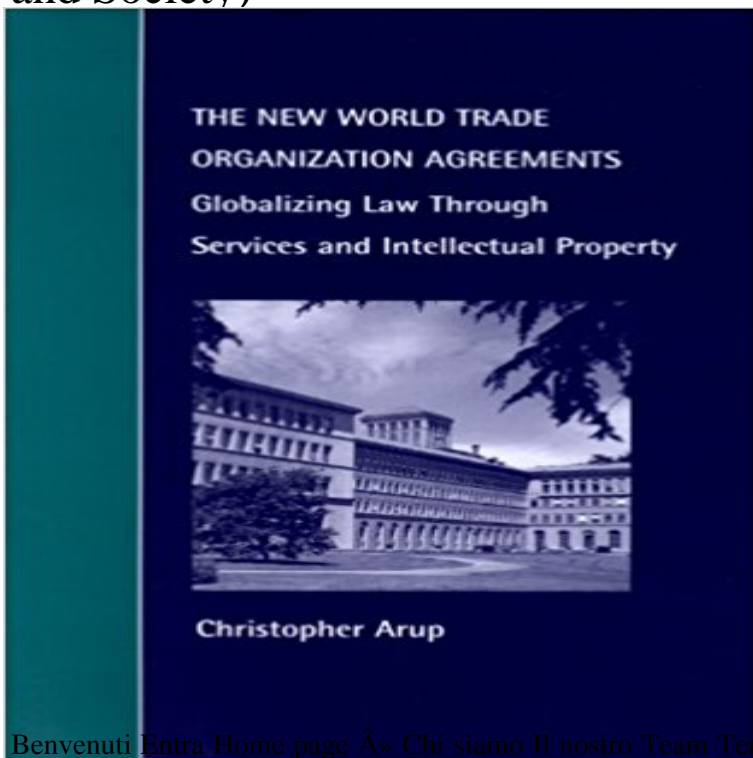


The New World Trade Organization Agreements: Globalizing Law through Services and Intellectual Property (Cambridge Studies in Law and Society)
