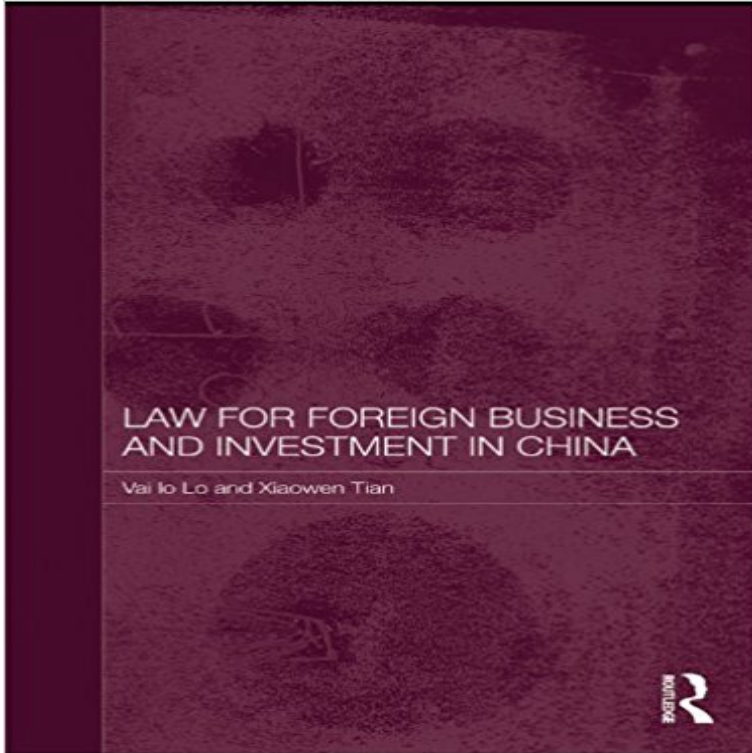


Law for Foreign Business and Investment in China (Routledge Contemporary China Series)
