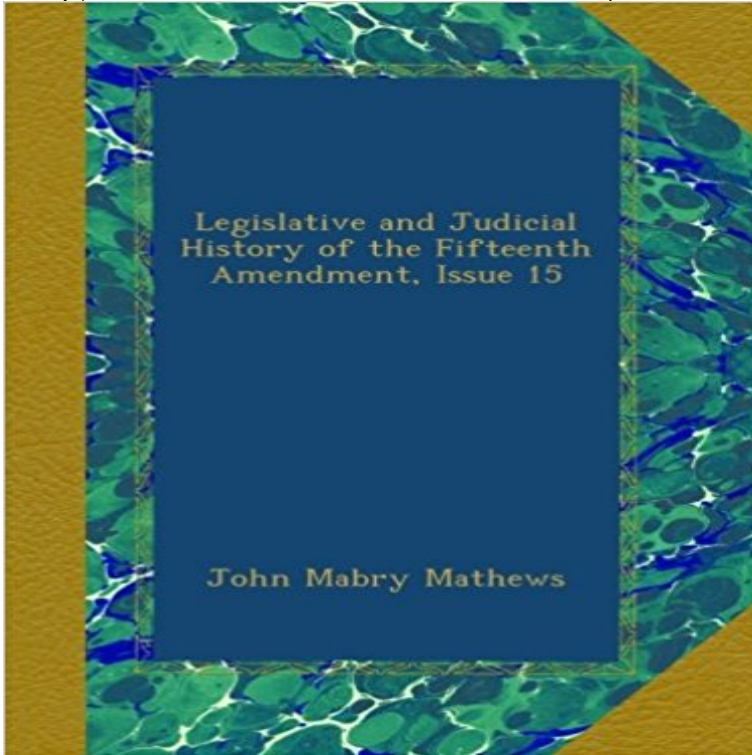


Legislative and Judicial History of the Fifteenth Amendment, Issue 15
