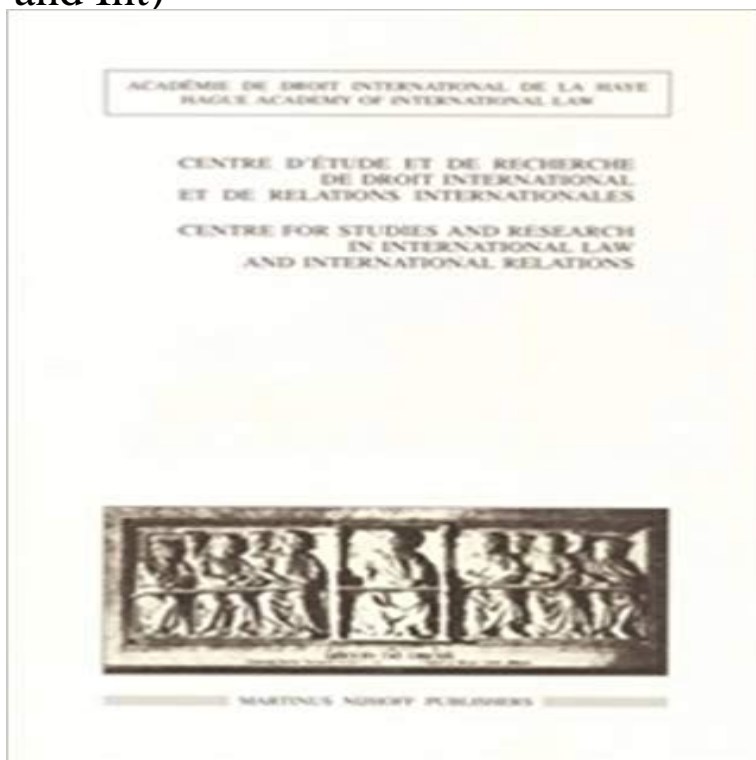


## The Legal Implications of 1993 for Member And Non-member Countries of the Eec 1991 (Centre for Studies and Research in International Law and Int)
