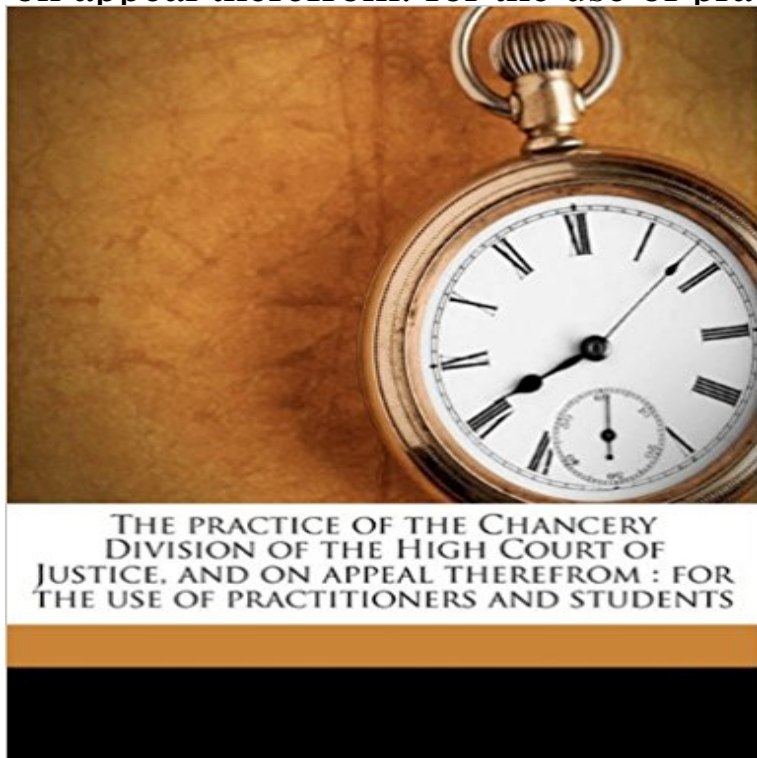


The practice of the Chancery Division of the High Court of Justice, and on appeal therefrom: for the use of practitioners and students
