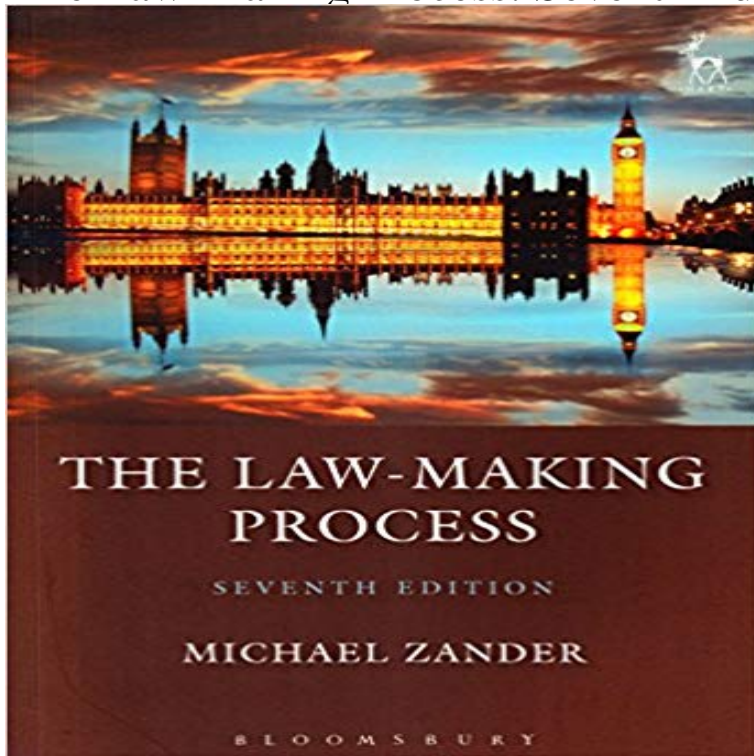


## The Law-Making Process: Seventh Edition
