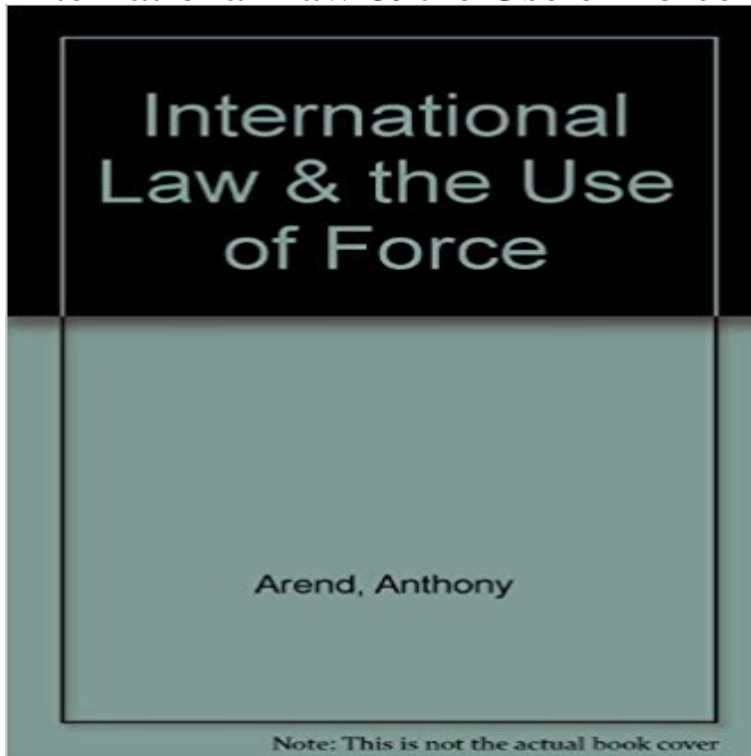


## International Law & the Use of Force
