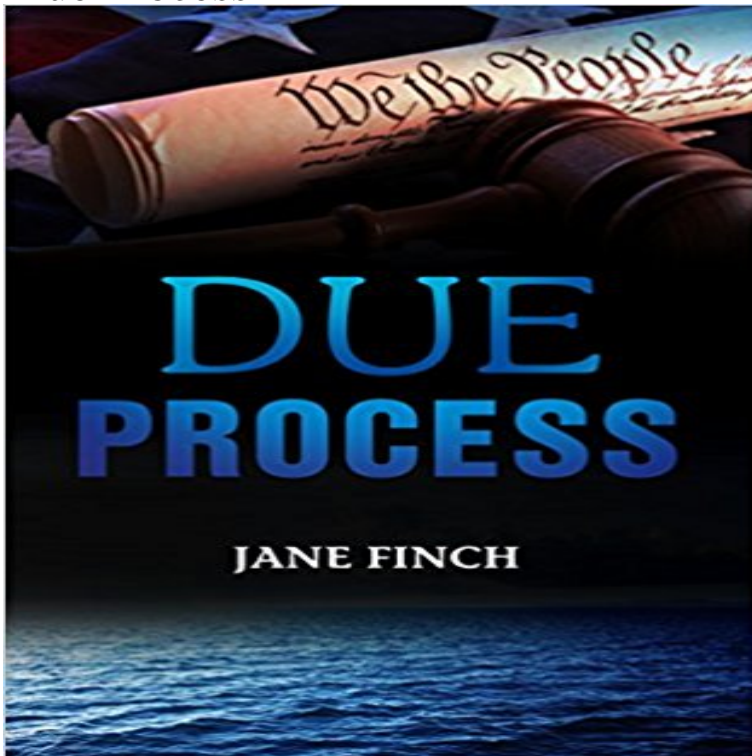


Due Process
