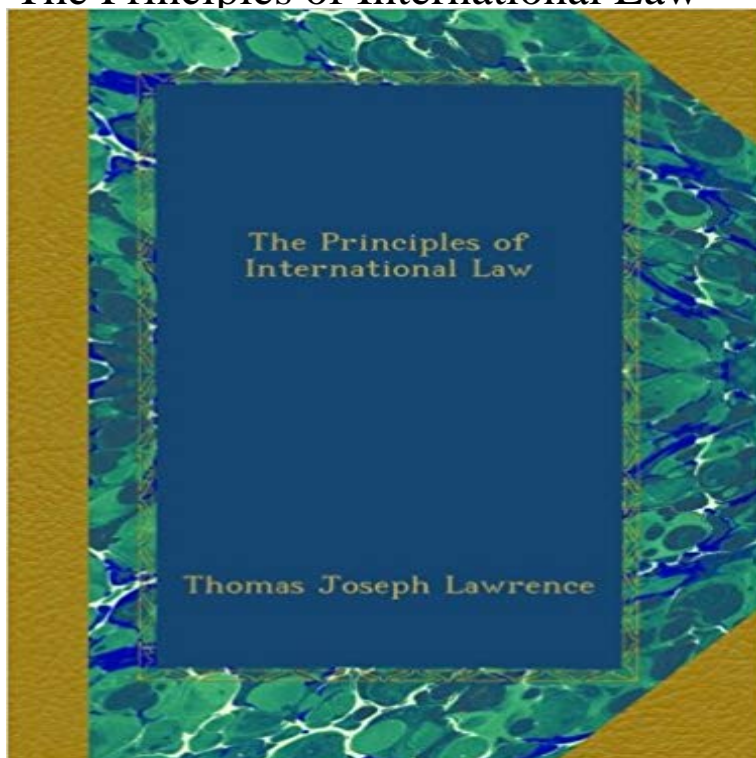


## The Principles of International Law
